In reference to the above and in continuation to this office letter no. 5495(24)-Home(Elec) dated 17.10.2019, I am to inform you that the Election Commission of India has reviewed the progress of Electors Verification Programme (EVP) and observed that large number of forms received for inclusion/ deletion/ correction are yet to be disposed of before draft publication. So, the Commission has decided to extend the period for completion of EVP and accordingly change the schedule for Special Summary Revision of Photo Electoral Rolls w.r.t. 01.01.2020 as qualifying date as per table given below.

I am to inform you that the Election Commission of India has conveyed vide letter No. 23/ECI/LET/TERR/ES-II/WB/2019-20 dated 10.12.2019, the approval for observing eight (8) Special Campaign dates on every Saturday and Sunday during the period for filing of claims and objections in SRER 2020. The Special Campaign days will be held on 21st December, 2019 (Saturday), 22nd December, 2019 (Sunday), 28th December, 2019 (Saturday), 29th December, 2019 (Sunday), 4th January, 2020 (Saturday), 5th January, 2020 (Sunday), 11th January, 2020 (Saturday), 12th January, 2020 (Sunday).

On the said days, the BLOs will be sitting at the respective polling stations from 11 am to 4 pm for receiving claims & objections. All recognized political parties may be requested to inform their BLAs to attend the Special Campaigns at Polling Stations to facilitate the work. A BLO-BLA meeting will be held in this regard at 12.00 noon at the polling stations on all the Special Campaign dates.

I am further to request you to kindly arrange for wide publicity of the campaign days and all concerned may be informed accordingly.
