

# Integrated Child Protection Scheme (ICPS)

## Salient Points

The ICPS structures to be instituted at the District Level by constituting District Child Protection Society (DCPS) - The fundamental unit at the district level for implementation of the scheme through:

- District Child Protection Committee (DCPS) for monitoring and liaison with DCPS
- Block Level Child Protection Committee (BLPC) for monitoring and liaison with DCPC
- Village / Ward level Child Protection Committee (VLCPC) for monitoring and liaison with DCPC/BCPC.
- DCPS will function through the above committees.

In pursuance of Notification No- 450- SW date 01.02.2010 read with Notification No. 1140-Sw dated 15.03.2010, District Child Protection Society has been formed on 19.04.2010 in Bankura District.

Juvenile Justice Board - JJB is already constituted and functioning.

Special Juvenile Police Unit- SJPU is already constituted and functioning.
