**Subject :-** Approved rate for supply of stationary articles for the period w.e.f. 01.04.2012 to 31.03.2014 selection of suppliers in respect of the offices of the District Magistrate & Collector, Bankura and the Sub-ordinate Offices under administrative control of the District Magistrate, Bankura.

The under noted suppliers have been selected to supply the stationary and other articles for office use as stated above. The suppliers are requested to submit their consent within 7(seven) days from the date of issue of the order whether they are agreed to supply the articles of the lowest rate so determined. In case of Non-receipt of the consent it will be treated that he hasno consent and his name will be struckoff from the list of the approved suppliers. It is also noted that if any soppliers will fail to supply the requested articles against supply order within 5 (five) days that order will stand rejected.

List of suppliers as well as the approved rate will cease to have effect after 31.03.2014 unless it is revalidated vide order of the authority concerned.


The suppliers are directed not to supply the spurious and substandard articles.

They are also directed to supply the earmarked articles as noted in the Tender. They will also mark the seal of the firm of the articles supplied by them. The articles so ordered should be delivered to the Forms & Stationary Section at their own cost and to the indenter directly. In case of failure their name will be Black Listed and their security will be forfeited.

This order will take effect on and from 01.04.2012. The list of suppliers as well as the approved rates will remain valid upto March' 2014 from the date of the order subject to extension of the validity till finalization of the rates for the next term.
