NOTICE

In terms of sub-section 3(ca) of section 68 the Motor Vehicles Act, 1988 the Regional Transport Authority of Bankura has formulated the following routes. Application for permit for the individual route is hereby invited from the intending person possessing or willing to possess vehicle of Bharat stage II norms.

Only one permit will be issued for each route. Mere submission of application for permit shall not be a binding on the RTA, Bankura to issue permit to the applicant. The RTA, Bankura reserves the right to reject any or all of the applications.

The application should be made in prescribed proforma, Form-1 and be submitted in sealed covers, mentioning serial No. and name of the route on the top of the envelop, with the following self attested documents by 22.12.2009 during office hours in the office of the undersigned. (By bank draft)

1. Receipt of deposit of application fees of Rs.2000.00 and security deposit of Rs.2000.00 in MV section, Bankura
2. Photo copy of voter identity card & ration card.
3. Sketch map of the proposed route
4. List of stoppages
5. Proposed time table
6. Registration Certificate, Fitness Certificate and tax token of the vehicle for which permit sought for (if the vehicle is in possession).
7. Affidavit as to placement of vehicle within 30 days from the date of issue of "OFFER" letter
8. Affidavit as to already holding of any Permanent Stage carriage permit.
9. Affidavit swearing that the proposed vehicle is not covered under any P.St.P (if the vehicle is in possession).
10. Affidavit by the land owner as to garage the vehicle.
11. Statement of bank A/C to show latest bank balance (if vehicle is already not in possession).
12. Consent letter of any bank to finance the vehicle (if vehicle is already not in possession).
